



Terms and Conditions for Charity Place Participants

Event entry

Registration fees for charity places in events are non-refundable and non-transferrable. They cannot be transferred to someone else or deferred to the following year other than in exceptional circumstances. If you're unable to participate due to injury or any other issue, you must let us know as soon as possible so we can cancel your place or offer it to someone on our waiting list.

You participate in this event at your own risk. The Miscarriage Association cannot be held responsible for any injury or illness resulting from your participation in the event. If you are granted a charity place, you agree that you will undertake suitable preparation before participation on the day and consult your GP if you have any concerns regarding health or injury.

Sponsorship

We purchase charity places for various events throughout the year to help our fundraisers participate in their favourite events, and the sponsorship we derive from these investments is a vital part of our income. We set our fundraising targets realistically, and in line with other similar charities. If our participants do not reach their sponsorship targets then it impacts on the services we can offer, so please think about how you might achieve your target and be confident that you can do so before accepting a charity place with the MA.

The minimum fundraising requirement for our charity runners in the TCS London Marathon 2026 is £2,000, including a none refundable £50 registration fee. We would expect that at least 75% of your sponsorship will be raised before the event date, utilising a bespoke Just Giving Team page link which we will supply, and the deadline for final sponsorship payments post-race is six weeks. If you have raised less than 50% of the target a month prior to the event date, we will contact you to discuss how we can help you to improve this. Please note that you are committed to raise a minimum of £2,000 and any shortfall will have to be paid to the charity by yourself, so please ask if you need help before then!

Event organisers

In the event of a place being offered, after registering with the Miscarriage Association, you will be required to sign up to, and comply with, the event organiser's event rules and/or terms and conditions. Please read these carefully, as they will set out the event organiser's obligations and liabilities to you and vice versa. If you don't complete the registration on the event organisers console, then you will not be able to take part in the event. Please note that the Miscarriage Association is not responsible for any aspect of the organisation or management of the event.

Marketing, photography, and sharing your stories

Sharing your fundraising stories with us to use on social media and in other promotional materials really does encourage new fundraisers, so we would appreciate it if you could send us some photos of your event and a couple of paragraphs about your experience once you have recovered. We are always delighted to receive your stories, and our service users find them really inspirational.
